C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a

significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Other: (explain, if not covered above): According to the NWI map, the subject parcel is mapped for both a riverine aquatic resource and emergent wetlands that would be directly adjacent to the riverine resource. Although there is evidence that emergent wetlands may exist on the parcel and in the vicinity of the project, there are no indications of riverine habitat on the property. There are no signs of a defined bed/bank and no channelized surface water flow on the subject parcel and adjacent parcels on the east side of Highway 20. The NWI map shows the riverine channel crossing the railroad tracks and Highway 20, and although aerial imagery appears to show culverts crossing both the railroad tracks and the highway, it is not clear if there are culverts that allow surface water flow to the west side of the highway. There are indications that a more defined channel exists on the west side of the highway, but none of the aerial imagery that was reviewed shows any surface water flowing within that channel. The NWI map and the USGS topo maps suggest that this riverine feature terminates in an agricultural field just south of E 1000 N, approximately 2.25 miles away from the subject parcel; review of aerial imagery further confirms that this riverine feature does in-fact terminate at this location. The terminus of this riverine feature is approximately 1.07 miles from the nearest surface water source that may have a connection to a larger downstream aquatic resource which may be considered a Water(s) of the U.S. Since this riverine aquatic resource terminates in an agricultural field and has no surface connection to a downstream Water(s) of the U.S., and the aquatic feature is far enough away from any other waters that may be considered jurisdictional, it would not be considered a jurisdictional water. Additionally, since the emergent wetlands are adjacent to this riverine aquatic resource and not adjacent to any other aquatic feature, the wetlands on the subject parcel would also not be a jurisdictional water

B. ADDITIONAL COMMENTS TO SUPPORT JD: Fremont County, specifically the Ashton area, is a rural part of Idaho with most of the land use being agricultural. There are several irrigation canals and ditches in the immediate area surrounding the subject land. With the large amount of irrigation input in the surrounding area, it results in pockets of wetlands on the landscape. Many of these wetlands may be jurisdictional, as they are adjacent to canals, ditches, rivers, and springs that have a surface water connection to larger Waters of the United States (U.S.). However, in cases like this, there are wetlands and other aquatic features that may hold water during certain seasons of the year, but they do not have a direct surface connection to a larger Waters of the U.S., and they terminate in uplands. It does appear that some wetlands may be present on the subject land, but after a review of several years of aerial imagery, there was never any observed surface water in what is classified by National Wetlands Inventory (NWI) as a riverine feature. Even if there was a riverine feature that these wetlands were adjacent to, and that riverine feature did have observed flows during the year, the mapped riverine feature appears to terminate in uplands with no clear surface connection to a Waters of the U.S. The terminus of this aquatic feature is not within a reasonable distance to a surface water source that may be considered a Waters of the U.S.
