- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The subject property contains the North Fork Five Mile Creek. This feature was determined to be isolated in April 2008 (DA# NWW-2008-00174). Information provided by the agent and observed during an on-site visit determined that the conditions of the resource and rational for isolation have not changed since the previous determination and that this segment with the review area is still isolated from downstream waters.

From the 2008 Approved Jurisdictional Determination:

"North Fork Five Mile Creek is a tributary to Five Mile Creek. Its watershed from the confluence with Five Mile Creek upstream to its headwaters consists of roughly 12 square miles. The drainage is located in a semi-arid area and receives on average 10 inches of precipitation each year. The North Fork Five Mile Creek from river mile 3.75 upstream to its headwaters is isolated, and no longer has any connectivity with the lower reach of its drainage. A very large gravel mining operation located on the west side of Interstate 84 has been operating since before 1976. The operation has excavated a pit in about 1/2 mile of channel effectively isolating the upper part of the creek. A second gravel pit located on the east side of Interstate 84 has also excavated about 1/2 mile of the creek channel. A 2007 aerial photo attached as Enclosure A clearly shows the drainage ends in a man-made retention pond on the east side of the railroad tracks which is immediately east of the large gravel pit located on the eastside of Interstate 84. Although a concrete box culvert still exists under Interstate 84, this culvert is no longer functional since flows from the stream ends in the retention pond (See Enclosure B). From the gravel pit upstream for approximately one mile the stream has been highly altered and relocated. The stream where it crosses under East Columbia Road has a discontinues channel with no defined bed and bank, see photo Enclosure C, and is not considered to be a waters of the United States from this point upstream to its headwaters even if the gravel pit had not isolated the drainage roughly 2 miles downstream. There are no wetlands along the North Fork Five Mile Creek. Based on the above, the North Fork Five Mile Creek from river mile 3.75 upstream to its headwaters is isolated, with no direct surface connection with any other water, does not support interstate commerce and does not have a significant nexus to any TNW. Therefore, the North Fork Five Mile Creek from river mile 3.75 upstream to its headwaters is isolated and not subject to regulation under Section 404 of the Clean Water Act."

Contributing factors which inform the determination extend beyond the review area, however this determination is limited to only those portions within the subject properties.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Resources with the review area are limited to the North Fork Five Mile Creek and its upstream branches. This feature has been historically and continually separated from downstream waters by alterations from development, the freeway, and ultimately disconnected by two large gravel mines. This resource was previously determined isolated in 2008. Review of existing conditions, updated information from the agent and information available to Corps, has determined that the North Fork Five Mile Creek is an isolated segment within the review area.
