- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The 87-acre property was delineated to determine the presence or absence of regulated waters and wetlands. Historic and continued uses were limited to agricultural pasture and grazing. The site was managed by utilizing user ditches running along a higher elevation knoll (10-20 vertical feet higher) and flood irrigating to lower elevation drainage patterns. These user ditches have been abandoned; however, the length of use had established wetland conditions along the slopes of the hill (vegetation and soils). 12 Piezometers were installed within the property prior to the growing season in February and monitored through June. The maximum water table elevations were compared to the delineated wetlands and portions of the overall delineated wetland complex was determined to be irrigation induced and would revert to uplands now that source of hydrology was eliminated. Approximately 5 acres of the 25 acres of delineated wetlands were determined to be considered Preamble Waters, (Artificially irrigated areas which would revert to upland if the irrigation ceased) and therefore are not considered waters of the United States.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly

affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The 87-acre property was evaluated. The overall property is the headwaters of Mud Creek and is also supported hydrologically by diversions and seepage from the Lake Irrigation District Canal which borders the north of the property. Aquatic Resources were identified along well-established drainage patterns, controlled by elevation. Review of the information available to our office and following an in-person site visit confirmed that portions of the delineated wetlands (approximately 5 acres) are irrigation induced wetlands. The remaining portions (19.18 acres of PEM) are determined to be directly abutting Mud Creek and RPW which is a tributary to the North Fork Payette River. With the exception of one small portion (0.13 acres) which directly abuts the Clara Foltz Ditch which flows to Mud Creek.
