SUBJECT: Evaluation of U.S. Special Operations Command Joint Military Information Support Operations Web Operations Center (JMWC) (Project No. D2022-DEV0PD-0131.000)

We plan to begin the subject evaluation in May 2022. The objective of this evaluation is to determine whether the U.S. Special Operations Command's Joint Military Information Support Operations Web Operations Center (JMWC) supports the combatant commander's requirements to conduct military information support operations (MISO).

We will perform this evaluation through interviews with the offices of the Assistant Secretary of Defense for Special Operations/Low-Intensity Conflict, U.S. Special Operations Command, combatant commands, the Joint Staff, and DoD partners and conduct site visits at select combatant command headquarters and JMWC locations. We may identify additional stakeholders and locations during the evaluation.
