1 Mar 22  1	1stMarDiv	At a general court-martial at Marine Corps Base Camp Pendleton, a military judge convicted Lance Corporal M. J. Walker, pursuant to the accused's plea, of rape and sexual abuse of a child. Consistent with the plea agreement, the military judge sentenced the accused to a dishonorable discharge, 12 years of confinement, and reduction to E-1.
4 Mar 22  2	1stCEB, 1stMarDiv	At a special court-martial at Marine Corps Base Camp Pendleton, a military judge convicted Lance Corporal D. A. Fiallo, pursuant to the accused's pleas, of wrongfully using controlled substances and conspiring to distribute a controlled substance. Consistent with the plea agreement, the military judge sentenced the accused to a bad conduct discharge, 6 months of confinement, forfeiture of \$1,100 pay per month for 12 months, and reduction to E-1.
8 Mar 22  3	2dSupBn, 2dMLG	At a special court-martial at Marine Corps Base Camp Lejeune, a military judge convicted Lance Corporal B. J. Deblanc, pursuant to the accused's plea, of unlawful entry. Consistent with the plea agreement, the military judge sentenced the accused to a bad conduct discharge, 165 days of confinement, and reduction to E-1.
9 Mar 22  4	2dMarDiv	At a general court-martial at Marine Corps Base Camp Lejeune, a military judge convicted Lance Corporal K. M. Cinkowski, pursuant to the accused's pleas, of sexual abuse of a child not involving sexual contact, possession, receiving, or viewing child pornography, and production of child pornography. Consistent with the plea agreement, the military judge sentenced the accused to a bad conduct discharge, 16 months of confinement, total forfeiture of all pay and allowances, and reduction to E-1.
10 Mar 22  5	3dMLG	At a general court-martial at Marine Corps Base Camp Foster, a military judge convicted Lance Corporal J. W. Dudley, pursuant to the accused's pleas, of larceny, burglary, indecent conduct, and indecent viewing. Consistent with the plea agreement, the military judge sentenced the accused to a dishonorable discharge, 21 months of confinement, total forfeiture of all pay and allowances, and reduction to E-1.
11 Mar 22  6	WFTBn, MCRD PI	At an Art. 16(c) (2) (A) special court-martial at Marine Corps Recruit Depot Parris Island, a military judge acquitted a Marine of all charges and specifications.

15 Mar 22 7	4thMarReg, 3dMarDiv	At a special court-martial at Marine Corps Base Camp Foster, a military judge convicted Lance Corporal J. A. Rojas, pursuant to the accused's pleas, of failure to obey a lawful order and failure to obey a lawful general order. Consistent with the plea agreement, the military judge sentenced the accused to 126 days of confinement and reduction to E-1.
20 Mar 22 8	MARCORLOGCOM	At a general court-martial at Marine Corps Recruit Depot Parris Island, a military judge acquitted a Marine of all charges and specifications.
22 Mar 22 9	8thMarReg, 2dMarDiv	At a special court-martial at Marine Corps Base Camp Lejeune, a military judge convicted Private A. L. Brooks, pursuant to the accused's pleas, of breaking restriction and wrongful use of controlled substances. Consistent with the plea agreement, the military judge sentenced the accused to a bad conduct discharge and 83 days of confinement.
24 Mar 22 10	1stMLG	At a general court-martial at Marine Corps Base Camp Pendleton, a military judge convicted Corporal R. E. Denson II, pursuant to the accused's plea, of abusive sexual contact. Consistent with the plea agreement, the military judge sentenced the accused to a dishonorable discharge, 79 months of confinement, total forfeiture of all pay and allowances, and reduction to E-1.
28 Mar 22 11	HqBn, 1stMarDiv	At a special court-martial at Marine Corps Base Camp Pendleton, a military judge convicted Lance Corporal D. C. Un, pursuant to the accused's pleas, of violating a lawful general order and wrongful use of a controlled substance. Consistent with the plea agreement, the military judge sentenced the accused to a bad conduct discharge, 3 months of confinement, forfeiture of \$1,000 pay per month for 4 months, and reduction to E-1.
29 Mar 22 12	CLR-3, 3dMLG	At an Art. 16(c) (2) (A) special court-martial at Marine Corps Base Camp Foster, a military judge convicted Lance Corporal N. J. Nordberg-Sanchez of dereliction in the performance of his duties. The military judge sentenced the accused to forfeiture of \$568 pay per month for one month.
31 Mar 22 13	3dMAW	At a general court-martial at Marine Corps Air Station Miramar, a military judge convicted Gunnery Sergeant D. J. Keil, pursuant to the accused's pleas, of violating lawful general orders and extramarital sexual conduct. Consistent with the plea agreement, the military judge sentenced the accused to a bad conduct discharge, 165 days of confinement, and reduction to E-3.

Adams, pursuant to the accused's pleas, of communicating a threat, domestic violence, violation of a protection order, unlawful entry, and violation of a lawful order. Consistent with the plea agreement, the military judge sentenced the accused to a bad conduct discharge and 85 days of confinement.</p>
<p>31 Mar 22</p> <p>15</p>	<p>FHG MARFORRES</p>	<p>At a special court-martial at Marine Corps Base Quantico, a military judge convicted Sergeant J. E. Burnett, pursuant to the accused's pleas, of making a false official statement and wrongful appropriation. Consistent with the plea agreement, the military judge sentenced the accused to a fine of \$9,167 and reduction to E-1.</p>
