SUBJECT: Attestation Review of the DoD Counterdrug Program FY 2022 Budget Formulation Compliance Reports (Project No. D2023-D000FT-0015.000)

We plan to begin the subject review in October 2022. We will perform this review in accordance with the Office of National Drug Control Policy Circular “National Drug Control Program Agency Compliance Reviews,” September 9, 2021. The Circular requires the DoD to provide a budget formulation compliance report to the Director of the Office of National Drug Control Policy. The objective of the review is to attest to the reliability of the assertions made in each of the DoD Budget Formulation Compliance Reports in conformity with the Office of National Drug Control Policy Circular “National Drug Control Program Agency Compliance Reviews.” We will perform the review in accordance with attestation standards established by the American Institute of Certified Public Accountants and in compliance with generally accepted government auditing standards. We will perform sufficient work to express a conclusion and provide limited assurance as to the reliability of each assertion made by the DoD in the Budget Formulation Compliance Reports for FY 2022. To provide limited assurance, the procedures we perform will be generally limited to inquiries and analytical procedures. We may revise the objective as the attestation proceeds, and we will also consider suggestions from management on additional or revised objectives.

We will perform the review at the Offices of the Assistant Secretary of Defense (Health Affairs), Deputy Assistant Secretary of Defense (Counternarcotics and Global Threats), and Defense Security Cooperation Agency, and at DoD Components involved in the National Drug Control Program. We may identify additional locations during the review.

Please provide us with a point of contact for the review within **5 days** of the date of this memorandum. The point of contact should be a Government employee—a GS-15, pay band equivalent, or the military equivalent.
