3 Aug 22  1	8thCommBn, II MIG, II MEF	At an Art. 16(c) (2) (A) special court-martial at Marine Corps Base Camp Lejeune, a military judge convicted Gunnery Sergeant E. E. Tennyson, of violating a lawful general order. The military judge sentenced the accused to a reprimand.
3 Aug 22  2	1stMarDiv	At a general court-martial at Marine Corps Base Camp Pendleton, a military judge convicted Lance Corporal E. Nina, pursuant to the accused's pleas, of wrongful introduction, distribution, possession, use, and conspiracy to distribute controlled substances. Consistent with the plea agreement, the military judge sentenced the accused to a bad conduct discharge, 12 months of confinement, total forfeiture of all pay and allowances, and reduction to E-1.
4 Aug 22  3	SOI-W, TrngCmd	At an Art. 16(c) (2) (A) special court-martial at Marine Corps Base Camp Pendleton, a military judge convicted Private First Class A. D. Sesay II, pursuant to the accused's plea, of assault consummated by battery. Consistent with the plea agreement, the military judge sentenced the accused to 45 days of confinement, forfeiture of \$1,222 pay per month for 1 month, and reduction to E-1.
4 Aug 22  4	1stBn, 4thMar, 1stMarDiv	At a special court-martial at Marine Corps Base Camp Pendleton, a military judge convicted Private First Class M. M. Saldivar, pursuant to the accused's pleas, of wrongful use of controlled substances and obstruction of justice. Consistent with the plea agreement, the military judge sentenced the accused to a bad conduct discharge, 7 months of confinement, forfeiture of \$1,000 pay per month for 7 months, and reduction to E-1.
5 Aug 22  5	HQBn, 1stMarDiv	At a special court-martial at Marine Corps Base Camp Pendleton, a military judge convicted Corporal B. T. Leal Jr., pursuant to the accused's pleas, of violating a lawful general order and wrongful distribution of a controlled substance. Consistent with the plea agreement, the military judge sentenced the accused to a bad conduct discharge, 5 months of confinement, and reduction to E-1.
9 Aug 22  6	HqSptBn, MCI-E	At a special court-martial at Marine Corps Base Camp Lejeune, a military judge convicted Private First Class J. A. Deleon Jr., pursuant to the accused's pleas, of breaking restriction, willfully disobeying a superior commissioned officer, and violating a lawful general order. Consistent with the plea agreement, the military judge sentenced the accused to reduction to E-1.

9 Aug 22 7	1stCEB, 1stMarDiv	At an Art. 16(c) (2) (A) special court-martial at Marine Corps Base Camp Pendleton, a military judge acquitted a Marine of all charges and specifications.
16 Aug 22 8	TrngCmd	At a general court-martial at Marine Corps Base Quantico, a panel of members convicted Sergeant J. A. Aguilar of assault with an unloaded firearm, making false official statements, and extramarital sexual conduct. The members sentenced the accused to a bad conduct discharge, 1 year of confinement, total forfeiture of all pay and allowances, and reduction to E-1.
18 Aug 22 9	WRR	At a general court-martial at Marine Corps Recruit Depot San Diego, a panel of members acquitted a Marine of all charges and specifications.
19 Aug 22 10	1stMLG	At a general court-martial at Marine Corps Base Camp Pendleton, a military judge convicted First Lieutenant C. F. Patterson of indecent recordings. The military judge sentenced the accused to a dismissal and 36 months of confinement.
23 Aug 22 11	TrngCmd	At a special court-martial at Marine Corps Air Ground Combat Center Twentynine Palms, a military judge convicted Private First Class R. Zamudio, pursuant to the accused's pleas, of conspiracy to distribute a controlled substance and wrongful distribution of a controlled substance. Consistent with the plea agreement, the military judge sentenced the accused to a bad conduct discharge, 9 months of confinement, forfeiture of \$1,000 pay per month for 12 months, and reduction to E-1.
24 Aug 22 12	2dMLG	At a general court-martial at Marine Corps Base Camp Lejeune, a military judge convicted Sergeant A. M. Cunningham, pursuant to the accused's pleas, of distribution, production, and possessing of child pornography, rape of a child, and indecent conduct with a child. Consistent with the plea agreement, the military judge sentenced the accused to a dishonorable discharge, 21 years of confinement, total forfeiture of all pay and allowances, and reduction to E-1.
29 Aug 22 13	1stMaintBn, 1stMLG	At a special court-martial at Marine Corps Base Camp Pendleton, a military judge convicted Lance Corporal B. J. Beacham, pursuant to the accused's plea, of unauthorized absence. Consistent with the plea agreement, the military judge sentenced the accused to a bad conduct discharge, 55 days of confinement, and reduction to E-1.
29 Aug 22 14	3dMLG	At a general court-martial at Marine Corps Base Camp Butler, a military judge convicted Lance Corporal J. H. Lumpkin Jr., pursuant to the accused's plea, of sexual assault of a child. Consistent with the plea agreement, the military judge sentenced the accused to a dishonorable discharge, 187 days of confinement, total forfeiture of all pay and allowances, and reduction to E-1.

29 Aug 22  15	MAG-39, 3dMAW	At a special court-martial at Marine Corps Base Camp Pendleton, a military judge convicted Lance Corporal C. S. Scott, pursuant to the accused's pleas, of wrongful possession and use of controlled substances. Consistent with the plea agreement, the military judge sentenced the accused to a bad conduct discharge, 6 months of confinement, forfeiture of \$1,200 pay per month for 6 months, and reduction to E-1.
