**irrigation runoff ditch that ran on the East side of the property through the pond and North to the Lenroot Canal. The connection to the irrigation runoff ditch was severed and filled to reroute the canal more directly into the Lenroot Canal. The upland pond now receives hydrology from ground water only when the irrigation drainage ditch is flowing. USACE visited the site during the peak of runoff for the Rexburg area and zero water was present. USACE has determined that the pond/wetland on the property meets the definition of a preamble non water.**

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Due to the information provided above, USACE has determined that this pond meets the definition of a non water under Section 328.3(d) as an “Artificial reflecting or swimming pools or other small ornamental bodies of water created by excavating and/or diking dry land to retain water for primarily aesthetic reasons.” .
