The Teton River forms from several interstate waterways (Trail, Fox, Dick, Teton, Creeks) originating in Wyoming and other streams in Idaho (Little Pine, Warm, Mahogany, and Horseshoe), converging between Victor and Driggs, Idaho to form the Teton River. This river supports water based interstate fishing and recreation in the form of small normally non-motorized watercraft, including several commercial guide services. These small boats can navigate the entire length of the river to its terminus at the Henrys Fork and then the Snake River. A small hydroelectric facility exists on the river, operated by Fall River electric, and licensed by the Federal Energy Regulatory Commission.

##### 2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is “adjacent”:

The wetlands on the property under review are part of a contiguous band of perennial springs and wetland seeps that appear at the western edge of north south trending alluvial fans that originate on the Teton Mountain Range in Wyoming. National Wetland Inventory Mapping and site specific wetland mapping by NWW-RD provides evidence that this contiguous band of wetlands directly abuts the Teton River. Additionally, the wetlands of the subject area can be seen as wetlands contiguous to the Teton River on USGS Quad maps, NHD Waterbody maps, and IDFG Wetland Prioritization SCORP maps.

#### B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The streams that flow from the mountains surrounding the Teton Valley form large alluvial fans as the topography begins to flatten in the valley. The slowing of this water encourages subsurface flows many of which resurface

as springs to form wetlands and stream channels that ultimately flow into the Teton River. The wetlands on site are a section of this greater wetland hydrology mosaic that directly abuts the Teton River and are therefore adjacent. Dick Creek is shown as perennial creek on USGS Quad maps as well as NWI maps and is a direct tributary of the Teton River. The Teton River is a TNW that supports a myriad of recreation opportunities such as public and private fishing, paddling, rafting, and wildlife viewing. The Teton River is tributary to the Henrys Fork or North Fork of the Snake River. The Snake River flows into the Columbia River, which terminates in the Pacific Ocean. .
