The Idaho Falls Regulatory Office received a delineation report on 11/17/2022 from Tamsen Binggeli (T-O Engineers, Inc.) on behalf of the Idaho Falls Airport.

The delineation was performed on a survey area approximately 9.7 acres in size. There are three hydrologic features on the property one drainage ditch and 2 depressional wetlands that serve as stormwater drainage basins making up 0.58 acres of palustrine emergent wetlands and 0.08 acres of palustrine forested wetlands. The property is presently undeveloped, located west of Interstate 15 and east of the Idaho Falls Airport. Topography is essentially flat (small topographic relief), though a berm that the interstate runs on top of is present on the east side of the survey area. The Porter Canal is the nearest water body approximately 636 feet to the east of the project area and the Snake River a TNW is another 150 feet east of the Porter Canal. The National Wetland Inventory (NWI) did not map any wetlands as occurring within the project area.

The flows on the survey area can only be traced from the drainage ditch into the depressional wetlands. The source of hydrology for the survey area is not well understood at this time and appears to be a combination of ground water and irrigation water. The wetlands are separated into two distinct areas depressional wetland 1 and depressional wetland 2 in the southeast and southwest corners of the property respectively. The drainage ditch flows directly into depressional wetland 1 and at this point surface flow appears to terminate. Depressional wetland 2 receives hydrology from either sheet flow or ground water from depressional wetland 1. There is no culvert allowing flows to connect beneath the interstate 15 berm. Nor are there surface connections to the north or south as those areas have already been developed with aviation infrastructure. The wetlands are isolated from TNWs and Waters of the United States.

The current use, past use, or susceptible use in interstate or foreign commerce has been considered, evaluated, and determined that no reasonable contribution to current, past or future interstate or foreign commerce occurs within the non-navigable, intra-state wetlands and pond. Per 33 CFR 328.3(a)(3)(i-iii), the evaluation included recreational activities, fish and shellfish production, industrial uses, and other uses. The wetlands within the review area total 0.66 acres and contain fragmented habitat near the interstate and within other airport infrastructure. Due to the roadway activity near the wetlands the degraded habitat would not provide reasonable migratory bird habitat nor furbearer habitat. There is no documented recreation including bird watching, hunting, or trapping within the wetlands. Also, no fish production, shellfish production or industrial uses are documented with the wetlands located in the review area.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Based on a review of the delineation received on 11/17/2022 as well as multiple years of satellite imagery, it has been determined that the water features found within the review area are not jurisdictional under Section 404 of the Clean Water Act. The flows from drainage ditch 1 that enter depressional wetlands 1 and 2 do not have an outlet. Therefore, no connection could be found to any downstream TNW.
