MEMORANDUM FOR DISTRIBUTION

SUBJECT: Audit of Remote Maintenance and Distribution Cell–Ukraine Restructuring Contract (Project No. D2023-D000AX-0116.000)

The purpose of this memorandum is to notify you that we plan to begin the subject audit in May 2023. The objective of this audit is to determine whether Army contracting personnel, in accordance with Federal and DoD policies:

- a. properly awarded the U.S. Army Tank—Automotive and Armaments Command (TACOM) contract (Contract W56HZV-22-D-ER04, Task Order W56HZV-23-F-0077) for the maintenance of equipment at Remote Maintenance and Distribution Cell—Ukraine,
- b. appropriately planned for and established controls to conduct surveillance of contractor performance, and
- c. effectively monitored contractor performance.

We may revise the objective as the audit proceeds, and we will also consider suggestions from management for additional or revised objectives. We plan to perform this audit in accordance with the Government Accountability Office's generally accepted government auditing standards.

We will perform the audit at TACOM Detroit, Michigan; the Army Contracting Command Rock Island, Illinois; the U.S. European Command Stuttgart, Germany; and Jasionka, Poland. We may identify additional locations during the audit.

We request that you designate a staff member to serve as our point of contact for this audit within **5 days** of this memorandum. The point of contact should be a Government employee—a GS-15, pay band equivalent, or military equivalent—and knowledgeable of Contract W56HZV-22-D-ER04, Task Order W56HZV-23-F-0077.
