SUBJECT: Audit of the Army's Management of Force Provider Modules in U.S. Central Command (Project No. D2024-D000RJ-0118.000)

The purpose of this memorandum is to notify you that we plan to begin the subject audit in April 2024.

The objective of this audit is to assess the effectiveness with which the Army managed the maintenance, storage, and accountability of Force Provider modules stored in U.S. Central Command area of responsibility in accordance with DoD and Army requirements. We may revise the objective as the audit proceeds, and we will also consider suggestions from management for additional or revised objectives. We plan to perform this audit in accordance with the Government Accountability Office's generally accepted government auditing standards.

We will perform this audit at Camp Arifjan, Kuwait. We may identify additional locations during the audit.

We request that you designate a staff member to serve as our point of contact for this audit within **5 days** of this memorandum. The point of contact should be a Government employee—a GS-15, pay band equivalent, or military equivalent—and knowledgeable of Force Provider modules as related to the objective.
