<u>10.14.1.</u> Conditions. After the death of the dependent, continue to pay a with-dependent housing allowance at the rate that is applicable to the member as if the sole dependent had not died and if:

10.14.1.1. such sole dependent dies while the member is on active duty; and

10.14.1.2. such sole dependent dies while physically residing with the member, unless separated by the necessity of military service, or to receive institutional care as a result of disability or incapacitation or under such other circumstances as determined by the Secretary concerned; and

<u>10.14.1.3.</u> the member is not occupying Government quarters on the date of death of the sole dependent.

<u>10.14.2.</u> Termination. The continuation of the with--dependent rate of housing allowance will terminate upon the earlier of the following:

<u>10.14.2.1.</u> The day that is one year after the date of the death of the sole dependent.

<u>10.14.2.2.</u> The permanent change of station, or permanent change of assignment with movement of personal property and household goods authorized under 37 USC §453(c) as otherwise stated in this chapter.

10.14.3.3. The member subsequently occupies permanent Government quarters.

<u>10.14.3.4.</u> The member claims another dependent for housing allowance purposes.

SUBJECT: Temporary Continuation of Rate of Basic Allowance for Members of the Armed Forces Whose Sole Dependent Dies While Residing with the Member

• **Purpose.** Request you initial below, approving language for inclusion in the Department of Defense Financial Management Regulation (DoD FMR), Volume 7A, Chapter 26 to implement section 613 of the James M. Inhofe National Defense Authorization Act for Fiscal Year 2023.

Background.

- Prior to enactment of section 613 of the James M. Inhofe National Defense Authorization Act for Fiscal Year 2023, a member receiving a housing allowance (basic allowance for housing or overseas housing allowance) at the with-dependent rate whose sole dependent died, ceased as of the date of the dependent's death to be entitled to a housing allowance at the with-dependent rate and became entitled to the allowance at the without-dependent rate.
- Section 613 authorizes the member to continue to receive the housing allowance at the rate in
 effect on the date of the dependent's death for up to 365 days, provided the dependent lived
 with the member or was authorized to live separately under certain circumstances, and the
 member did not occupy a government housing facility on the date of death.
- The intent of the new statute (37 U.S.C. §403(m)) is to provide financial relief to a Service member whose housing choices and financial obligations were based upon receiving a housing allowance at the with-dependent rate, but who subsequently lost his or her sole dependent. The continuation of the housing allowance would terminate either after 365 days, thereby allowing the member time to make other housing arrangements, or upon departing the current duty station on a permanent change of station order.
- The changes at TAB A update the Department of Defense (DoD) Financial Management Regulation (FMR), Volume 7A, Chapter 26 to authorize continued payment of a withdependent housing allowance under the circumstances authorized in statute.
