SUBJECT: Evaluation of the DoD's Validation of Repair Parts Requested by the Ukrainian Armed Forces (Project No. D2024-DEV0PD-0133.000)

The purpose of this memorandum is to notify you that we plan to begin the subject evaluation in June 2024. The objective of this evaluation is to determine the effectiveness of DoD Components' processes for verifying the need for, and the accountability of, repair parts requested by the Ukrainian Armed Forces to maintain military equipment provided by the DoD. We may revise the objective as the evaluation proceeds, and we will also consider suggestions from management for additional or revised objectives. We plan to perform this evaluation in accordance with Council of the Inspectors General on Integrity and Efficiency "Quality Standards for Inspection and Evaluation."

We will perform the evaluation at Security Assistance Group-Ukraine headquarters in Germany and its subordinate commands in Poland. We may also identify additional locations.

We request that you designate a staff member to serve as our point of contact for this evaluation within **5 days** of this memorandum. The point of contact should be a Government employee—a GS-15, pay band equivalent, or military equivalent—and knowledgeable of the subject related to the objective.
