

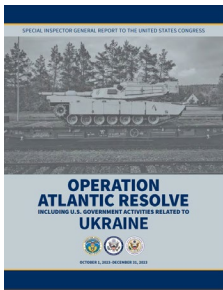


Oversight Update: Ukraine Assistance

This update summarizes recent DoD Office of Inspector General oversight activities related to DoD security assistance to Ukraine. Below are a few highlights.

Projects Released

In February, the DoD OIG released four projects:

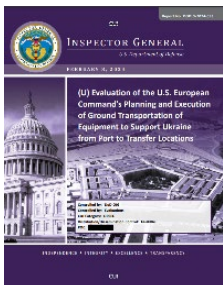


- [Operation Atlantic Resolve Quarterly Report for Congress](#)

This quarterly report discusses Operation Atlantic Resolve, including U.S. support for Ukraine, and the planned, ongoing, and completed oversight work over those efforts conducted by the DoD, State, and USAID Offices of Inspector General, as well as the other U.S. oversight agencies that coordinate their activities

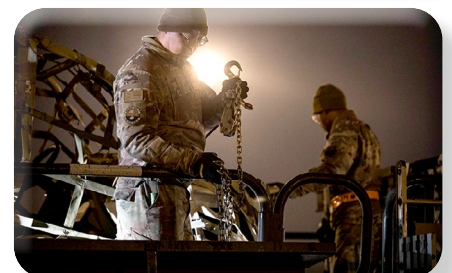
through the Ukraine Oversight Interagency Working Group.

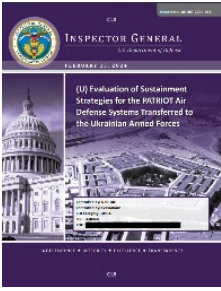
The U.S. Congress has appropriated approximately \$113.4 billion for the U.S. response to Russia's full-scale invasion of Ukraine. This funding supports security, economic, and humanitarian assistance to Ukraine and other countries affected by the war; the operations of U.S. Government agencies involved in the Ukraine response; the enhanced U.S. military presence and activity in Europe; the replenishment of U.S. military stocks transferred to the Ukrainian Armed Forces (UAF); and training of the UAF.



- [Evaluation of the U.S. European Command's Planning and Execution of Ground Transportation of Equipment to Support Ukraine from Port to Transfer Locations](#)

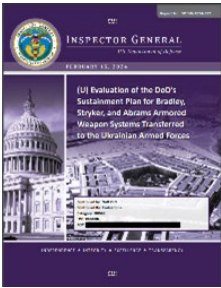
The evaluation reviewed the DoD's implementation of security and accountability controls for transportation of equipment bound for Ukraine from European seaport to ground transportation.

This evaluation reviewed the extent to which the DoD developed and implemented sustainment strategies in support of Phased Array Tracking Radar to Intercept on Target (PATRIOT) air defense systems transferred to the UAF.

This evaluation reviewed the extent to which the DoD developed and implemented sustainment plans to support Bradley, Stryker, and Abrams armored weapon systems transferred to the UAF.

Recently Announced Projects

[- Project Announcement: Follow-Up Evaluation of Enhanced End-Use Monitoring of Defense Articles Provided to Ukraine](#)

The objective of this evaluation is to determine the extent to which the DoD conducted EEUM of designated defense articles provided to Ukraine in accordance with DoD policy during the period after June 2, 2023.

[- Project Announcement: Evaluation of the Accountability of PDA Defense Equipment Deliveries to Ukraine](#)

The objective of this evaluation is to determine whether the Defense Security Cooperation Agency and the Military Services are effectively and efficiently accounting for the delivery of Presidential Drawdown Authority defense equipment to Ukraine in accordance with DoD property book and DSCA security assistance policy.

[- Project Announcement: Follow-up Evaluation of Management Advisory: Sufficiency of Staffing at Logistics Hubs in Poland for Conducting Inventories of Items Requiring Enhanced End-Use Monitoring](#)

This evaluation will assess the actions taken by the DoD to ensure that the Office of Defense Cooperation-Ukraine has sufficient capacity to effectively and efficiently conduct all required enhanced end-use monitoring inventories of designated defense articles prior to transfer into Ukraine.

[- Project Announcement: Follow-up Evaluation of Management Advisory: The Protection of Sensitive Mission Data by the Security Assistance Group-Ukraine and Its Subordinate Commands](#)

This evaluation will assess the extent to which the Security Assistance Group-Ukraine and its subordinate commands, in coordination with the U.S. Army Europe and Africa, have fully implemented plans and issued guidance to improve compliance with DoD information security policies.

In-Country Activities

DoD OIG personnel working at the U.S. Embassy in Kyiv conducted multiple meetings with stakeholders, including the Ukrainian Ministry of Defence (MoD) Main Inspectorate. Topics of interest included the responsibilities of the MoD for reporting, investigations, and anti-corruption.

DoD OIG personnel also met with Ukrainian Armed Forces (UAF) personnel to discuss the Self Reporting Concept of Operations (CONOPS) signed in April 2023. According to the CONOPS, UAF personnel are responsible for conducting initial inventories of all newly transferred, U.S. origin defense articles that require Enhanced End-Use Monitoring (EEUM) within five days upon arrival and on a quarterly basis they will inventory EEUM designated defense articles by serial number, except night vision devices, which will be inventoried semi-annually. The requirement is to inventory 100 percent of all defense articles over a one-year period.

The OIGs of the Department of Defense, Department of State, and U.S. Agency for International Development are committed to coordinating oversight of Ukraine aid. Get the latest on each OIG's planned, ongoing, and completed work at their respective websites.
