Authorized Funded Environmental and Morale Leave Locations and Destinations

A. Policy. Funded Environmental and Morale Leave (FEML) policy for DoD Service members is established in DoD Instruction 1327.06 “Leave and Liberty Policy and Procedures.”

B. Eligibility. FEML eligibility requirements for Uniformed Services, DoD civilian employees, and dependents are specified in the Joint Travel Regulations, paragraph 04040, Table 4-11, and this document.

C. Authorized Period. Each location in the table is an authorized FEML location until removed from the list, regardless of the recertification date shown next to the destination.

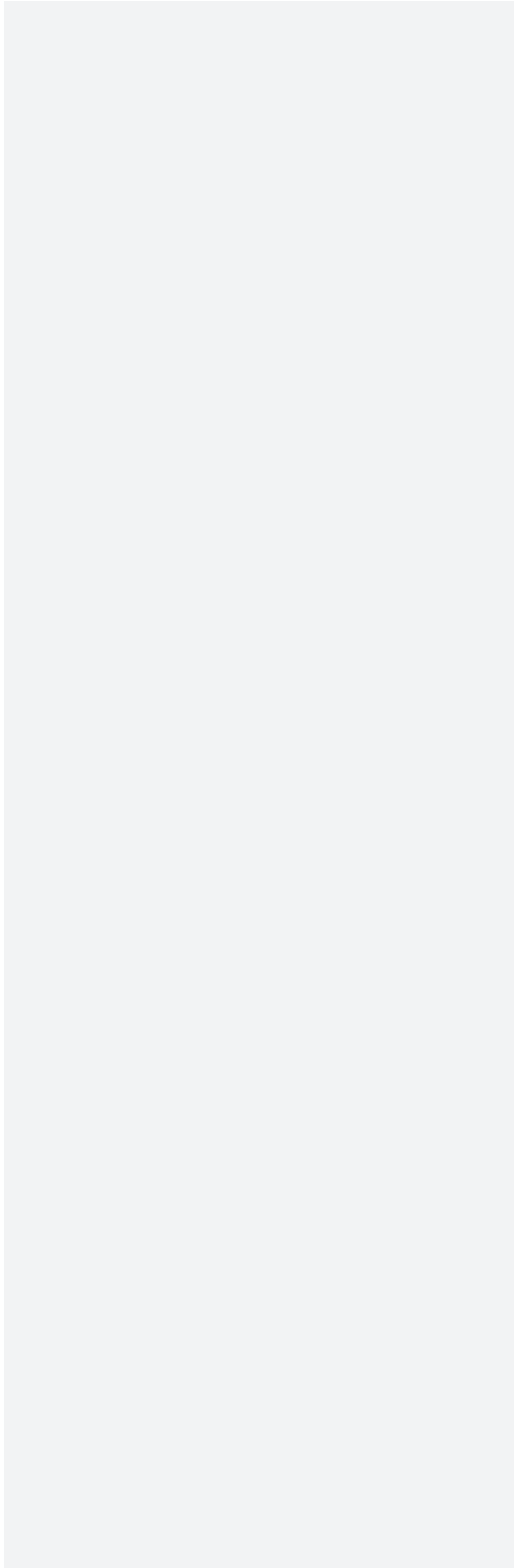
