SUBJECT: UTD for MAP 101-23(R), “Temporary Lodging Expense (TLE) Extension – Vandenberg SFB, CA (CA026)”

1. Purpose: This item reinstates the Vandenberg SFB, CA Military Housing Area (MHA) CA026 as a location to receive an extended Temporary Lodging Expense (TLE) under the authority in 37 U.S.C. § 452(b)(11). Due to a shortage of housing in the Vandenberg SFB, CA MHA, personnel require additional time to locate and secure permanent housing. This item reinstates Vandenberg SFB, CA as a location to receive up to 60 days TLE.
