MEMORANDUM FOR: MILITARY ADVISORY PANEL

SUBJECT: UTD for MAP 96-23(R), “Temporary Lodging Expense (TLE) Extension – Bath, ME (ME136)”

1. Purpose: This item reinstates the Bath, ME Military Housing Area (MHA) ME136 as a location to receive an extended Temporary Lodging Expense (TLE) under the authority in 37 U.S.C. § 452(b)(11). Due to a shortage of housing in the Bath, ME MHA, personnel require additional time to locate and secure permanent housing. This item reinstates Bath, ME as a location to receive up to 35 days TLE.
