I am pleased to introduce the FY 2025 Oversight Plan for the Department of Defense Office of Inspector General (DoD OIG). This plan presents the planned and ongoing audits and evaluations that align with our statutory requirements and the FY 2025 DoD Top Management and Performance Challenges.

We selected the projects in our annual oversight plan by assessing the most significant risks to DoD management and performance, including issues related to the ongoing conflict in Ukraine and escalating tensions from adversaries in the Indo-Pacific region. We also considered previous oversight work, the potential benefits of selected projects, and feedback from Congress and senior DoD leaders. We plan to continue to focus our discretionary oversight in FY 2025 on U.S. security assistance to Ukraine and programs and operations related to the U.S. Indo-Pacific Command. While this oversight plan lists our intended activities for FY 2025, our approach to oversight planning is dynamic and allows us to quickly adapt to new developments and provide agile and responsive oversight of the areas most impactful to the DoD. Therefore, we may adjust our oversight projects based on emerging priorities and the availability of personnel and resources to ensure our efforts remain relevant and effective.

Beyond the planned oversight work listed in this document, the DoD OIG also engages in a range of other oversight and enforcement activities. Our responsibilities include operating the DoD Hotline; investigating criminal activity, senior official misconduct, and whistleblower reprisals; and providing education on fraud awareness and whistleblower rights and protections.

Through all these efforts, we work to achieve our mission of conducting independent and impactful oversight that promotes the economy, efficiency, and effectiveness of DoD programs and operations, and the integrity of its personnel.

Introduction

This Oversight Plan is the outcome of our annual planning process during which the DoD OIG selects oversight projects on both a deliberate and dynamic basis. It presents the audits and evaluations we intend to conduct in FY 2025 and considers prior oversight work, statutory requirements, DoD strategy and priorities, resource availability, and the OIG's assessment of the DoD's top management and performance challenges (TMPC). Our plan promotes transparency by informing the DoD, Congress, and the public about our planned and ongoing work, and helps to identify opportunities for collaboration and de-confliction with our oversight community partners within the DoD and beyond.

As a complement to our annual oversight planning activities, the DoD OIG has an agile process that enables us to respond to emerging requirements and feedback, including new statutory requirements, DoD Hotline complaints, and stakeholder requests. Combined, our annual oversight plan and dynamic project development process ensure that our oversight work covers the most critical programs and operations in the DoD.


In the overview of the plan, we discuss the overall content and distribution of the oversight activities planned for FY 2025. Next, we present focus areas that call for a more comprehensive oversight approach, due to their immediate and continuing significance to DoD operations. Lastly, we list all of the DoD OIG's planned and ongoing projects, organized by the FY 2025 TMPC.

In addition to this plan and in coordination with our OIG partners at the Department of State and the U.S. Agency for International Development, we prepare oversight plans specific to our overseas contingency operations—the Combined Oversight Plan for Overseas Contingency Operations for Operation Inherent Resolve and Operation Enduring Sentinel, and the Joint Strategic Oversight Plan for Operation Atlantic Resolve, including U.S. security assistance to Ukraine.

Overview of the FY 2025 Oversight Plan

The FY 2025 Oversight Plan identifies 101 planned projects—57 audits and 44 evaluations—and 153 ongoing projects, which represent work initiated in prior fiscal years. Of our planned and ongoing projects, 53 are nondiscretionary, as they are required by statute. The remaining projects are discretionary in nature and, therefore, dependent on available personnel and resources. The distribution of discretionary and nondiscretionary projects is depicted in Figure 1.

Figure 1. The Distribution of Planned and Ongoing Oversight Projects by Discretionary Status





Our annual assessment of the DoD's TMPC, conducted pursuant to the Reports Consolidation Act of 2000, is the main organizing principle for the Oversight Plan. The FY 2025 TMPC are:

- 1. Increasing Military Readiness
- 2. Strengthening the Capabilities and Capacities of Allies and Partners
- 3. Protecting Defense Critical Infrastructure
- 4. Improving Financial Management
- 5. Improving Quality of Life for Military Families
- 6. Building the Future Force


Figure 2. The Distribution of Planned and Ongoing Projects by TMPC

The distribution of projects by TMPC is depicted in Figure 2. This includes projects classified as "Miscellaneous," which are mostly nondiscretionary peer reviews and quality control reviews and do not align with this year's TMPC.

Although the DoD OIG's oversight focus has been directed toward U.S. security assistance to Ukraine and activities in the U.S. Indo-Pacific Command (see "DoD OIG Focus Areas"), DoD OIG oversight activities continue across the DoD's broad range of geographic and functional operations. Figure 3 depicts Combatant Command-specific projects but does not include general projects that cover all Combatant Commands or the DoD most broadly.

DoD OIG Focus Areas

The DoD OIG's mandate involves oversight of the full scope of DoD programs and operations. As the DoD conducts a broad range of global activities, our oversight responsibilities are equally broad—from audits of nuclear systems to evaluations of military housing to investigations of international cyberattacks. The critical importance of particular concerns, however, necessitates our selection of focus areas to best use finite resources and to ensure we deliver timely, impactful oversight. Based on assessments of both emerging and enduring concerns, for FY 2025 we will continue to focus our discretionary oversight on programs and operations related to security assistance to Ukraine and the U.S. Indo-Pacific Command (USINDOPACOM).

While we have identified a wide range of topics within these two oversight focus areas for FY 2025, it is important to note that oversight planning is a continual process, which provides the flexibility during the year to initiate new projects not listed in this plan.

OPERATION ATLANTIC RESOLVE

In December 2023, the DoD Inspector General, previously named Lead Inspector General for Operation Atlantic Resolve by the Chair of the Council of the Inspectors General on Integrity and Efficiency, was re-designated by Congress as the Special Inspector General for Operation Atlantic Resolve. The re-designation carried additional responsibilities and reporting requirements to ensure whole-of-government oversight of the Ukraine response and transparency of this complex and resource-intensive effort. We continue to prioritize our comprehensive oversight of DoD efforts related to Operation Atlantic Resolve, and in FY 2025, we intend to focus our work on the financial and materiel support provided to Ukraine, as well as the increased U.S. military presence and activities in Europe. Figure 4 highlights our Operation Atlantic Resolve-related oversight for FY 2025.

U.S. INDO-PACIFIC COMMAND

The Indo-Pacific region remains a strategic area of focus for the DoD OIG given its geopolitical significance and critical relationships with key allies and partners. The People's Republic of China has accelerated its military buildup in an effort to project power within the region and has adopted increasingly provocative behaviors, particularly in the South China Sea. In response, USINDOPACOM remains focused on deterrence, conducting activities that demonstrate and strengthen U.S. capabilities and commitment to the region. To ensure U.S. forces can successfully execute their diverse mission sets throughout USINDOPACOM, our projects are focused on facilities, equipment, operational support, and interoperability with allies and partners. Figure 5 highlights our USINDOPACOM-related oversight work for FY 2025.
