SUBJECT: Audit of the Army's Management of Repairs to Bradley Fighting Vehicles to Meet U.S. Army Europe and Africa Mission Requirements (Project No. D2025-D000AH-0030.000)

The purpose of this memorandum is to notify you that we are initiating the subject audit. The objective of this audit is to assess the effectiveness of the Army's management of repairs to ensure that Bradley Fighting Vehicles transferred to U.S. Army Europe and Africa units meet mission requirements. We may revise the objective as the audit proceeds, and we will also consider suggestions from management for additional or revised objectives. We plan to perform this audit in accordance with the Government Accountability Office's generally accepted government auditing standards.

We will perform the audit at the 21st Theater Sustainment Command, 405th Army Field Support Brigade, 409th Contract Support Brigade, Army Sustainment Command, and Army Contracting Command. We may identify additional locations during the audit.

We request that you designate two points of contact for this audit within **5 days** of this memorandum. One point of contact should be a Government employee—a GS-15, pay band equivalent, or military equivalent—who is knowledgeable of the Bradley Fighting Vehicle maintenance requirement in U.S. Army Europe and Africa. The second point of contact should be a member of the Senior Executive Service or a General/Flag Officer who is familiar with the Bradley Fighting Vehicle maintenance requirement and could serve as a point of engagement with DoD Office of Inspector General senior leaders, if necessary.
