MEMORANDUM FOR DISTRIBUTION

SUBJECT: Evaluation of DoD Processes to Provide Repair Parts to Support the Ukrainian Armed Forces (Project No. D2024-DEV0PD-0182.000)

The purpose of this memorandum is to notify you that we are initiating the subject evaluation.

The objective of this evaluation is to assess the efficiency and effectiveness of DoD processes for providing repair parts for U.S. equipment to Ukraine. We may revise the objective as the evaluation proceeds, and we will also consider suggestions from management for additional or revised objectives. We plan to perform this evaluation in accordance with Council of the Inspectors General on Integrity and Efficiency “Quality Standards for Inspection and Evaluation.”

We will perform the evaluation at Security Assistance Group–Ukraine headquarters in Germany and the Remote Maintenance and Distribution Center–Ukraine in Poland. We may also identify additional locations.

We request that you designate a staff member to serve as our point of contact for this evaluation within **5 days** of this memorandum. One point of contact should be a Government employee—a GS-15, pay band equivalent, or military equivalent—who is knowledgeable about DoD processes for providing repair parts for U.S. equipment to Ukraine. The second point of contact should be a member of the Senior Executive Service or a General/Flag Officer who is familiar providing repair parts to Ukraine and could serve as a point of engagement with DoD Office of Inspector General senior leaders, if necessary. Send each contact’s name, title, grade/pay band, phone number, and email address to [REDACTED]
