5 Nov 25 1	MARFORSOC	At an Art. 16(c)(2)(A) judge alone special court martial at Marine Corps Base Camp Lejeune, a military judge convicted GySgt Cesar M. FIERROS, contrary to the accused's pleas, of negligently damaging/destroying/losing military property of some value. The military judge sentenced the accused to reduction to E-6.
7 Nov 25 2	3d MAW	At a special court-martial at Marine Corps Air Station Miramar, a military judge convicted Sergeant G. M. Estrada, pursuant to the Accused's plea, of reckless driving. Consistent with the plea agreement, the military judge sentenced the accused to 30 days of confinement and reduction to the grade of E-3.
12 Nov 25 3	2d MARIDV	At a special court-martial at Marine Corps Base Camp Lejeune, a military judge convicted LCpl Ethan D. MARSH, pursuant to the accused's pleas, of violations of domestic violence- commission of a violent offense, and willfully disobeying a superior commissioned officer, consistent with the plea agreement, the military judge sentenced the accused to 30 days of confinement.
14 Nov 25 4	MCINCR-MCBQ	At a general court-martial at Marine Corps Base Quantico, a military judge convicted Corporal Luis E. Castillo, pursuant to the accused's pleas, of possessing, distributing, and producing child pornography, indecent recording, and sexual assault of a child. Consistent with the plea agreement, the military judge sentenced the accused to a Dishonorable Discharge, 180 months of confinement, total forfeitures, and reduction to E-1.
14 Nov 25 5	TRNG CMD	At a general court-martial at Marine Corps Base Quantico, a military judge convicted Private Jeremy A. Proulx, pursuant to the accused's pleas, of distribution of Schedule I/II/III controlled drugs. Consistent with the plea agreement, the military judge sentenced the accused to a Bad Conduct Discharge, and confinement for 89 days (time served).
17 Nov 25 6	8th Comm Bn, II MIG, II MEF	At a general court-martial at Marine Corps Base Camp Lejeune, a military judge convicted LCpl Emanuel VILLARREAL, pursuant to the accused's pleas, of violations of sexual abuse of a child by indecent conduct, possession of child pornography, solicitation of distribution of child pornography, consistent with the plea agreement, the military judge sentenced the accused to a dishonorable discharge, 7 years of

		confinement, total forfeitures, and reduction to E-1.
24 Nov 25 7	MCCSSS TRNG CMD	At a special court-martial at Marine Corps Base Camp Lejeune, a military judge convicted Pvt Jaylon M. BATESGORRITZ, pursuant to the accused's pleas, of violations of domestic violence-commission of a violent offense, and obstructing justice, consistent with the plea agreement, the military judge sentenced the accused a bad conduct discharge, and 53 days of confinement.
24 Nov 25 8	CLR-37, 3d MLG	At a special court-martial at Marine Corps Base Camp Butler, a military judge convicted Major B. J. Quinn, pursuant to the accused's pleas, of 1 specification of conspiracy to commit a false official statement under Article 81, UCMJ; 3 specifications of soliciting the commission of other offenses under Article 82, UCMJ; and 1 specification of conduct unbecoming of an officer under Article 133, UCMJ. Consistent with the plea agreement, the military judge sentenced the accused to no punishment.
25 Nov 25 9	2d MLG	At a special court-martial at Marine Corps Base Camp Lejeune, a military judge convicted LCpl Troysen SERAWOP, pursuant to the accused's pleas, of violations of larceny of non-military property of a value of more than \$1000 and larceny of non-military property of a value of \$1000 or less, consistent with the plea agreement, the military judge sentenced the accused a bad conduct discharge, 6 months of confinement, and reduction to E-1.
