3 Dec 25 1	1st Bn, 2d Marines, 2d MarDiv	At a General Court-Martial aboard Marine Corps Base Camp Lejeune, a Military Judge convicted LCpl A. J. ROSS of attempted extramarital sexual conduct and receiving child pornography. Consistent with the plea agreement, the Military Judge sentenced the accused to a dishonorable discharge, 12 months confinement, and reduction to E-1.
4 Dec 25 2	MARFORCYBER	At a special court-martial at Marine Corps Base Camp Pendleton, a military judge convicted Staff Sergeant A. R. Hamilton of unlawful entry. No punishment was adjudged.
4 Dec 25 3	CLR-37, 3d MLG	At a special court-martial at Marine Corps Base Camp Butler, a panel of members convicted Sgt J. D. Parker, contrary to the accused's pleas, of 1 specification of solicitation under Article 82, UCMJ; 1 specification of obstructing justice under Article 131b, UCMJ; and 4 specifications of maltreatment under Article 93, UCMJ. The military judge sentenced the accused to no punishment.
8 Dec 25 4	12th LLB, 3d MarDiv	At a special court-martial at Marine Corps Base Camp Butler, a military judge convicted PFC M. W. Barnes, pursuant to the accused's pleas, of 1 specification of possession of a controlled substance under Article 112a, UCMJ. Consistent with the plea agreement, the military judge sentenced the accused to a reduction to E-1.
9 Dec 25 5	MAG-26, 2d MAW	At a Special Courts-Martial aboard Marine Corps Base Camp Lejeune a Military Judge convicted Sergeant T. Hughes of larceny of military property of a value of more than \$1000, and of selling military property of a value of more than \$1000. Consistent with the plea agreement, the Military Judge sentenced the accused to a bad conduct discharge, 60 days of confinement, and reduction to E-1.
10 Dec 25 6	VMU-3, MAG-24, 1st MAW	At a special court-martial at Marine Corps Base Hawaii, a military judge convicted LCpl K. Wilson, pursuant to the accused's pleas, of 1 specification of failure to go to place of duty under Article 86, UCMJ; 1 specification of escape from pretrial confinement under Article 87a, UCMJ; 1 specification of contempt or

		disrespect towards a superior noncommissioned or petty officer under Article 91, UCMJ; 2 specifications of willful disobedience of a noncommissioned or petty officer under Article 91, UCMJ; and 2 specifications of failure to obey other lawful written order under Article 92, UCMJ. The military judge sentenced the accused to 90 days of confinement and reduction to E-1.
10 Dec 25 7	CLB 6, CLR2, 2d MLG	At a Special Courts-Martial aboard Marine Corps Base Camp Lejeune a Military Judge convicted Private First Class C. C. Vaughan of battery. Consistent with the plea agreement, the Military Judge sentenced the accused to a bad conduct discharge, and reduction to E-1.
12 Dec 25 8	2d AA Bn, 2d MarDiv	At a Special Court-Martial aboard Marine Corps Base Camp Lejeune, a Military Judge convicted Private First Class G. S. Bridges of indecent recording. Consistent with the plea agreement, the Military Judge sentenced the accused to a bad conduct discharge and reduction to E-1.
18 Dec 25 9	1st MARDIV	At a special court-martial at Marine Corps Base Camp Pendleton, a military judge convicted Lance Corporal K. D. Laster, pursuant to the accused's plea, of one charge of missing movement by neglect, and two specifications of unauthorized absence. Consistent with the plea agreement, the military judge sentenced the accused to a bad conduct discharge and 29 days confinement.
18 Dec 25 10	MCINCR-MCBQ	At a special court-martial at Marine Corps Base Quantico, enlisted members convicted Staff Sergeant Jonah W. Smith Jr., contrary to the accused's pleas, of Misappropriation of property of a value of \$1000 or less in violation of Article 121, and failure to obey other lawful written order in violation of Article 92. Accused was sentenced to forfeitures of \$500 for two months and a reprimand.
18 Dec 25 11	H&S Bn, SOI-East, Trng Com	At a Special Court-Martial aboard Marine Corps Base Camp Lejeune, a Military Judge convicted Private First Class D. D. Townsend, of contempt or disrespect towards a noncommissioned or petty officer, and disrespect towards a superior commissioned officer in command. The Military Judge sentenced the accused 5 days of confinement, and reduction to E-1.
19 Dec 25 12	I MEF	At a general court-martial at Marine Corps Base Camp Pendleton, a military judge convicted Lance Corporal D. J. Coleman, pursuant to the accused's plea, of two specifications of indecent recording. Consistent with the plea agreement, the military judge sentenced the accused to a

		Bad Conduct Discharge, 14 months confinement, and reduction to E-1.
19 Dec 25 13	2d Bn, 10 th Marines, 2d MarDiv	At a General Court-Martial aboard Marine Corps Base Camp Lejeune, a military judge convicted Sergeant J. G. Eaton, of larceny of military property of a value of more than \$1000, and selling or disposing of military property of a value of more than \$1000. Consistent with the plea agreement, the Military Judge sentenced the accused to a bad conduct discharge, 18 months of confinement, and reduction to E-1.
19 Dec 25 14	H&S Bn, SOI-East, Trng Com	At a Special Court-Martial aboard Marine Corps Base Camp Lejeune, a Military Judge convicted Private Z. U. Semans, of unauthorized absence terminated by apprehension (LIO), unauthorized absence of more than 3 days and up to thirty days, and use of a schedule I, II, II controlled drug. Consistent with the plea agreement, the Military Judge sentenced the accused 95 days of confinement.
30 Dec 25 15	1st MLG	At a special court-martial at Marine Corps Base Camp Pendleton, a military judge convicted Corporal F. T. Talamini, pursuant to the accused's plea, of wrongful appropriation of a motor vehicle in violation of Article 121, UCMJ. Consistent with the plea agreement, the military judge sentenced the accused to 60 days confinement, and reduction to E-2.
